Description

Extent:

Scope and Content: Collection of pamphlets and offprints collected by Sir Frank Ezra Adcock (1886- 1968) mostly relating to the history of Ancient Greece and Rome. Includes offprints sent to by Adcock by their authors. The collection has been arranged alphabetically by author.

History: Sir Frank Ezra Adcock (1886-1968) was a historian of Greece and Rome. He was born at Desford, Leicestershire, the son of Thomas Draper Adcock, schoolmaster, head of the Desford Industrial School, and his wife, Mary Esther Coltman. He was educated at Wyggeston grammar school, Leicester, and King's College Cambridge. In 1911, he was elected a fellow of his college and appointed a lecturer in classics in 1911. During World War I he worked for the intelligence division of the Admiralty as an interpreter of codes and ciphers. After the war, he became an editor of Cambridge Ancient History journal and was its chief editor from 1927 until his death. In 1925 he became the chair of Ancient History at Cambridge. During World War II, he was release from his chair to work for the Foreign Office. He returned to Cambridge in 1943 and became the president of the Classical Association from 1951-1955. He retired in 1951 and was knighted in 1954. Although he frequently contributed to Cambridge Ancient History, he rarely published his research elsewhere. He died in Cambridge on 22 February 1968.

His collection was donated to Lancaster University by the Council of King's College Cambridge in August 1968. Some of the original publications were moved to the main collection at some point in the 1970s.
