Scope and Content: Records collated by Stanley Lawrence during his research on the history of Burton-in-Lonsdale and nearby villages located on the Yorkshire/Lancashire border. Includes correspondence; published materials; Lawrence's own writings and notes; press clippings and articles, maps and plans of the area; and photographs.

Contains detailed information about pottery and land ownership in Burton-in-Lonsdale and materials about prominent families and people in the area, such as the Thornton family. It also contains information about corporations in the area, such as the Parish Council and the Settle Highway Board. The collection contains very little original documentation and are copies of materials held elsewhere which have been created or annotated by Lawrence.

Many of the series were further broken down into subseries, usually by records relating to people, place or corporations. Initially the records were not physically arranged into this order. Some records which were arranged into folders by Lawrence were classified into multiple series.

When the collection was reviewed in 2023, records in folders were arranged by the series in which their folder was classified. The structure was also simplified to remove unnecessary subseries.

Indexes of personal names, place names and subjects were created during the cataloguing process in 2001 and are available on request.

Provenance: Lawrence, Stanley G. (c.1926-2013)

History: Stanley G. Lawrence was born in the mid-1920s. He was the headmaster of Burton-in Lonsdale Endowed School (also known as Richard Thornton's School). He became a local historian of the local area in the 1940s. Around 1965, he began collecting and creating materials related to the history of the school, Burton-in-Lonsdale and the local area. He continued to collect materials until the late 1980s, although there were only a few additional materials added after 1976. Lawrence died on the 29th September 2013 at the age of 87 years.

Lawrence donated the collection to the University in 2000, as he wanted to pass on his work to allow other researchers and historians to use it. Previously the materials had been stored at Lawrence's home and had been rarely used since the 1980s. Apart from the record cards, he did not order the collection in any way. Additional accessions were received in 2002 and 2004.

The collection was catalogued in 2001 by Nicola Graham, with assistance and guidance from David Baron and Angus Winchester. The catalogue was completed on 28th May 2001. The catalogue was reviewed in 2023 as part of an audit of the collections held by the Special Collections and Archives. As part of the review, the hierarchy was simplified, and individual identifiers were allocated to records.

Conditions on Access: The collection is available to access by appointment in the Archive Research Centre in the Library of Lancaster University. Contact library@lancaster.ac.uk to access materials.

Conditions on Use: The donor gave the University permission to provide copies of materials which fall under his intellectual property. Permission to publish the materials should be sought from the University.

Note:

The collection was initially catalogued following the *ArchiveHub Data Creation Guidelines*, October 2000, and *ISAD(G): International Standard for Archival Description (General)*, International Council on Archives, 2000.

Even though many of the records are copies of original documents created from the 1960s, most of the records are dated by the date of the original document they were created from. It is believed that the documents were actually created from 1965, when Lawrence began his research into the local area.
