For example, individuals have a right to be told if personal information about them is being processed, and to have a copy of this information. Fair Processing Notice

Under the Data Protection Act (1998) schools, Local Authorities, the DCSF and other educational bodies that process personal data about pupils are required to issue parents with a Fair Processing Notice that explains to them and their child/children the purposes for which that personal data may be held and used. The website includes sample letters and information sheets that schools and others can use to explain what and how they will process personal data. The link provides an introduction for those new to data collection.

Connexions

As noted below Connexions have a role in tracking young people. A number of Aimhigher partnerships have negotiated access to data and worked with Connexions to record details of Aimhigher participants. This can be very effective, but requires careful planning and negotiation and a clear statement or fair processing notice. As noted below parents or pupils aged 16 or over have the right to opt out and withhold permission for data exchange.

For pupils of 13 years and over, the school is legally required to pass on certain information to Connexions services providers on request. This information includes the name and address of the pupil and parent, and any further information relevant to the Connexions services' role. However parents, or the pupils themselves if aged 16 or over, can ask that no information beyond name and address (for pupil and parent) be passed on to Connexions. If as a parent, or as a pupil aged 16 or over, you wish to opt-out and do not want Connections to receive from the school information beyond name and address, then please contact the school.

The LA and DCSF may supply to Connexions services providers information which they have about children, but will not pass on any information they have received from the school if parents (or the children themselves if aged 16 or over) have notified the school that Connexions should not receive information beyond name and address.
