Stakeholder Exchange

On 27 July 2012, a Stakeholder Exchange meeting was held at Gazegill Organics Farm in Rimington. 12 organisations attended including the RSPB, United Utilities, and Yorkshire Dales National Park. The purpose of the meeting was to look at the complexities involved in the use, protection and management of the Ribble Catchment. It also explored opportunities for action and ways of working together. We received strong support to continue a Ribble Catchment Stakeholder Exchange to help develop and implement a shared Catchment Action Plan for the Ribble. Tidal Ribble Workshop No.3


The third and final workshop for the Tidal Ribble 'Evidence and Measures' project was held on 14 August 2012. The project has focused on the tidal part of the Ribble River (the area of the Ribble influenced by the tides) from Lytham St. Annes to Longridge. This part of the Ribble is often forgotten about, but it is equally as important as other parts of the catchment for its impact on Lancashire's bathing waters. Using evidence and data to inform our knowledge and understanding of

issues affecting this part of the catchment, a series of specific actions have been identified by stakeholders and interested parties and will be included in the overall Ribble Catchment Action Plan.

Planning and the Water Framework Directive (WFD)

With the support of the Sustainable Places team within the Environment Agency, the Ribble Life project board has been exploring the possibility of developing a Supplementary Planning Document (SPD) with interested Local Authorities across the Ribble Catchment. A supplementary planning document is a local development document that can cover a wide range of issues, thematic or site-specific. Breathing new life into Burnley's rivers

A £1.4m. plan to revitalise rivers in Burnley town centre has been unveiled to the public by the Ribble Rivers Trust as part of the Urban River Enhancement Scheme (URES) which hopes to breathe new life into the town's rivers. The three-year URES project – one of the first of its kind in the country – will look to naturalise a 2.2km stretch of river through the town which was heavily developed during the Industrial Revolution.
