



## Top Tips for managing the REACT Group Discussion Forum

These have been put together by REACT supporters to help you get started

- Encourage kindness and be kind.
- **Be patient and keep a calm attitude with your approach.** If you feel yourself getting upset or angry, take some time to compose yourself and return when you feel able.
- Treat every member with the same respect and consideration. Encourage equal input from each member and treat those who break policies with understanding and fairness.
- Try to encourage new or uncertain members within discussions. Support good posts and add relevant and helpful commentary to a thread if it needs some reinforcement.
- Remember you're there to support the members but try to recognise when it's best to just step back and let them support each other.
- **Lead by example.** Be polite and non-judgemental in how you post to show others**Be firm** when users are abusing rules; exceptions lead to further abuse.
- Try to deliver clear, consistent comments and remain sensitive to how others may interpret your input as it could influence other's behaviours and the rest of the discussion. Remember that not everyone may share the same humour as you.
- **Remain Impartial.** Comments shouldn't be removed because they clash with your own personal beliefs or opinions.
- Ask for help from other moderators. This can be with regards to undertaking any action you are unsure of or is difficult to judge, however also if you are unable to read all of the forum's messages due to increased daily input.
- Remove content only if it has broken one of the community guidelines. However repeated unsuitable or irrelevant content should be discussed with members privately.
- Contact members if their post has broken the rules and has been removed as soon as possible. Let them know why the decision was made, remembering they may have broken the guidelines by accident. E.g. they may have included personal info without realising the potential risks.
- **Ensure that the REACT community guidelines are being upheld** not just by the members, but also by yourself and your fellow moderators.
- **Respond promptly to flagged issues and inappropriate content.** This could stop disputes escalating or ensure important conversations are encouraged to continue.
- **Do not provide advice on any matter,** other than forum guidance. Be aware of when you may be unintentionally giving advice in your comments. Where necessary you can signpost to appropriate, previously agreed suggestions.
- **Be aware of your Trust's risk protocols,** and talk to your line manager about anything you consider to be worrying.







## What is the IMPART study and how does it fit with REACT NHS?

The IMPART study is investigating how the REACT toolkit is implemented into Early Intervention Services as part of routine clinical practice in NHS Trusts. At the heart of the REACT NHS study is the aim of providing relatives with information and peer support so that they are less distressed. A paper version of the REACT Toolkit was shown to significantly reduce distress in a feasibility study. However paper versions of information are harder to keep up to date and do not provide an opportunity to access peer support though group forums.

We aim to understand what factors support successful delivery of REACT to relatives The findings will have broader implications for understanding how other similar interventions can be implemented.

To do this we will be inviting people in the Trusts and friends and family who are offered or using the REACT Toolkit to take part in interviews and we will carry out detailed analysis of what happens in each NHS Trust during the process of adopting the REACT intervention.

### The objectives of the study are to:

- Measure the uptake and use of REACT by NHS EIS teams and relatives.
- Identify the critical success factors, facilitators and barriers to implementation of REACT.
- Identify the resources (and costs) needed for successful implementation of REACT in EIS teams.
- Investigate the impact of REACT on self-reported relatives' outcomes.
- Develop a user friendly REACT Implementation Plan and related resources to facilitate widespread use and dissemination within the NHS.
- Use the findings from this study to further develop theories of implementation of supported self-management interventions in the NHS.




Go to www.reactnhs.uk, select your Trust and Log in and follow the instructions below.

1. Go to the dashboard by clicking the 'Dashboard' button on right hand side of the menu bar

2. Click on 'Relative Invites' on the left hand side of the dashboard or the link circled.





#### What to do if an invite has not been accepted?



It may be that the email has gone into their junk or spam folder. The questions below have been suggested by other EIS teams and relatives and are really useful for finding out more.


- 1. **Did you get the REACT email?** If **no** could it have gone into your junk/spam folder? What email providers are you using? This is so we can see if we can see if there is a way to stop REACT emails going into Junk.
- 2. Did you open the email?
- 3. Was it easy to follow what to do to get onto REACT?
- 4. What was it about REACT that meant you didn't get onto it?
- 5. We are really interested on what makes someone want to use REACT or not. Would you be happy to take to one of the researchers about this?



When a relative goes to www.reactnhs.uk they have the option to log in if they have been sent an email invite or Request Access

Someone will be in contact with you shortly. Best wishes from the REACT team"


















#### **Current dashboard:**


- Grey colour ,Vague labels that are unclear,

- REACT invites > Pending invites or create invite
- Pending invites only shows invites that you have issued that have not yet been accepted
- To find relatives who have accepted you would need to look on 'Users' > 'Intervention relative'



#### New dashboard:


- Bright blue colour
- More detailed labels (e.g. blog posts, resource directory, user accounts) and 'REACT invites' changed to 'Relative invites'
- Information on front page of dashboard including relative quotes, trust-wide information (invites, registrations, accessing REACT) and instructions to create a new invite and link to the how to manual. These boxes can be re-arranged to your liking.
- Audit function quick summary on dashboard and link to more detailed information via the 'view' button. Under 'Relative invites' > 'My relatives' shows relatives that you have invited including pending, accepted and accessing. 'Audit relatives' shows all pending, accepted and accessing relative invites in

your Trust.




