### **INTRODUCTION**

### 1. WELCOME AND APOLOGIES

- 1.1 Council <u>noted</u> the apologies for absence received for this meeting.
- 1.2 The Chair advised that both Valerie Young and Ian Johnson would be completing their terms as members of the Council on the 31 July 2022, he expressed great appreciation for both Valerie Young and Ian Johnson's long service to Council, including as chairs of council sub-committees and contributing to many other Council working groups and activities.
- 1.3 Council <u>welcomed</u> the new student members of Council, Students' Union President, India Ellis and Students' Union Vice-President Welfare, Victoria Phillips.
- 1.4 Council <u>welcomed</u> incoming Council lay members Alun Branigan and Adrian Jonas to the meeting noting they would be observing as part of their induction programme.
- 1.5 Council <u>welcomed</u> James Fuller who was observing the meeting as part of his induction to his new role of Executive Support Officer.

1.6 The Chair <u>noted</u> that a quorum of the Council was present for a meeting in accordance with Statute 9.7 and accordingly that the meeting was duly convened.

#### 4. MATTERS ARISING

- 4.1 **Item 6 Students' Union President's Report**: Council <u>noted</u> that the Pro-Chancellor and Vice-Chancellor had given further consideration to engagement with the Students' Union for the forthcoming academic year, and it had been discussed in part through the Lay Members Working Group recommendations and conditions.
- 4.2 **Item 13 Safeguarding Training and Induction**: Council <u>noted</u> safeguarding training had been embedded into the induction programme for all Council members.

# 5. VICE-CHANCELLOR'S UPDATE AND QUESTIONS TO THE EXECUTIVE

- 5.1 Council <u>noted</u> the written report from the Executive circulated on 1 July 2022. The Vice-Chancellor reported on the following.
  - (i) The appointment of the Rt. Hon. James Cleverly as the Secretary of State for Education and the Rt. Hon. Greg Clark, as the Secretary of State for Levelling Up, Housing and Communities with the Rt. Hon Kwasi Kwarteng remaining as the Secretary of State for Business, Energy and Industrial Strategy.
  - (ii) Universities UK's response to the Government and Office for Students' concerns regarding grade inflation with a pledge to return to pre pandemic levels by 2023.
  - (iii) The progress of 2023 pay negotiations, where a significant gap remained between staff unions' demands and employers' perspectives on affordability. Council advised that it wished to be kept abreast of matters relating to industrial relations.
  - (iv) His recent trip to Malaysia for the Sunway and Lancaster Universities' degree ceremonies.
  - (v) Restricted and Commercial in Confidence

- (vi) The publication of the 2022 National Student Survey (NSS) Results where the University's position for student satisfaction had risen from 14<sup>th</sup> to 11<sup>th</sup> and it had been ranked 1<sup>st</sup> for learning resources and 12<sup>th</sup> for teaching. Council noted that a focus was required on assessment and feedback, and this would be considered as part of the curriculum transformation programme.
  - Council encouraged further consideration of how the positioning of learning resources as part of our offer to the student experience could be optimised.
- (vii) The intention to facilitate Council's engagement with Universities UK's Representative for International Development Professor Steve Smith, to provide further insight into international collaborations.
- 5.2 Council <u>noted</u> the report from the Vice-Chancellor.
- 6. PRESIDENT, LANCASTER UNIVERSITY STUDENTS' UNION: ORAL REPORT
- 6.1 The President provided an oral report on the new Students' Union Officers' goals and priorities for 2022/23 based on the four key issues they had identified for students:
  - (i) concerns regarding the cost of living and ensuring money was not a barrier to students' education;
  - (ii) student safety both on campus and within the city;
  - (iii) ensuring that students across all faculties received a consistently high quality of education and parity of opportunity regarding academic-related processes and services; and
  - (iv) supporting students' social lives post-pandemic and enabling them to build social capital and life skills.

The President highlighted the Students' Union's intention to develop a strategy to address these concerns through a Trustee Board Away Day and made clear that she and her fellow officers shared a desire to rebuild trust and an effective working relationship with the University in the interest of all students.

6.3 Council warmly welcomed the President's positive approach and <u>noted</u> the Students' Union Officers' priorities.
