- 11.1 Senate received a proposal to change the name of the Department of Languages and Cultures to the School of Global Affairs. This, it was noted aligned with FASS strategic planning associated with answering global challenges. The School would provide a sustainable home for language studies, an area under considerable pressure nationally and internationally, while also appealing to the needs and expectations of current students. The name reflected an engagement with an emerging interdisciplinary field and would signal an opportunity to bring interdisciplinary expertise into the department without creating internal competition.
- 11.2 Senate noted that there was no change in structural terms. Clarity that the new name would provide would enhance the visibility of subject and the diet of programme would also be reviewed to ensure this. The rebrand would help sustain a future market, particularly catering to those students who want to take language as an element of study.
- 11.3 It was noted that the exact date for transition had not been given in the paper. This would be agreed outside of Senate in discussion with the relevant parts of the University (Marketing, Admissions, etc.).
